Entry: All works must be delivered by hand to Wilkes Art Gallery, 913 C Street, North Wilkesboro, NC

Entry Drop Off Dates:

Friday, February 26 from 10am to 4pm

Saturday, February 27 from 10am to 1pm

Monday, March 1 from 10am to 2pm

Entries will not be accepted after 2pm on Monday, March 1.

Pick Up: All unselected works should be picked up Wednesday and Thursday, March 3 & 4 from 10am to 4pm or March 9 from 10am to 4pm. Unselected works may also be picked up during the Opening Reception on Friday, March 5. All works not sold must be picked up on either Saturday, April 17 from 10am to 1pm or Tuesday, April 20 from 10am to 4pm.

SPECIFICATIONS

1. Artists may enter up to three works in each of the three divisions. **Division I:** Paintings, Drawings, Mixed Media and Original Prints. Mixed media works will be accepted into this category at the discretion of the juror. **Division II:** Pottery, Sculpture and Fibers and **Division III:** Photography.
2. Two-dimensional works must be matted, framed and wired for hanging. Three Dimensional Works must stand alone, be assembled and ready to exhibit. Works are not to exceed 60" in any direction, including framing.
3. All works must be original and completed within two years of the opening date of the exhibition. Works must not have been accepted for exhibit in previous Northwest Artist's League Competitions.
4. All works must have an indicated value regardless of being available for sale. Use "From the collection of the artist" or "Courtesy of Mr. and Mrs. John Doe" rather than "Not for sale."
5. Mark selling price to include a 30% commission retained by the Wilkes Art Gallery.
6. Entering artists may submit up to 3 works in each division.
7. Artist's signature on each entry form verifies accuracy of information.
8. Works not picked up by June 30, 2010 will become property of Wilkes Art Gallery.
9. Entry labels must be attached to the center back of each entry. The manifest must be completed and submitted to Gallery staff.
